Recommendation

Before initiating the measures for submitting a financing application, the eligibility criteria should be carefully verified and analyzed regarding both the applicant and the project. For instance, in the case of certain financing a review of the relevant legislation pertaining to small and medium enterprises is necessary, so that to confirm that the potential applicant is eligible as per the criteria set forth by the guide. Moreover, the legal and fiscal documentation submitted along with the financing application need to be valid as of the submission date and to give evidence of the accurate compliance with the prerequisites in the guide.



Modernizing agricultural production

Recommendation

European financing does not cover the entire value of the project to be implemented. Therefore, before submitting the project, the applicant should make sure that it can sustain out of its own sources the other expenditures related to the project or/and that the investments thereon and the implementation form also fulfill the conditions imposed by the credit institution for granting a loan (including any guarantees requested by the credit institution). In case one fails to consider this aspect, the chances for the project to be finalized are endangered, while non-fulfillment over time of the undertaken commitments might even lead to the termination by the competent authority of the financing contract.

Recommendation

During the project implementation phase, the beneficiary needs to comply with the procurement regulations (and with the public procurement relevant legislation, where applicable). Failure to comply with such rules may result in the refusal from relevant authorities to reimburse the expenses made by the beneficiary for the purpose of the project and may also generate litigation with the authority with which the financing contract is concluded.

The beneficiary of the financing should comply with the terms agreed under the financing agreement regarding the project implementation, as well as with the other obligations set forth by the said agreement, so that to avoid the application by the authority of measures to which it is entitled according to the agreement, such as contract and/or payments suspension, claiming the full reimbursement of the amounts received as non-refundable financing, applying penalties as percentage of the non-refundable eligible value, or recovery of undeserved amounts.
